In terms of Section 14(1) of the NCTE Act, 1993, Mata Gujri Memorial College of Education, Village- Balwanda, PO+ Chack-Sharelf, Block - Kahnuwan, Distt.- Gurdaspur (Punjab) had submitted an application (Code No. APNO1847) to the Northern Regional Committee of NCTE for grant of recognition for starting B.Ed. Course of 2006-07 year duration with an annual intake of 100 students.

- 2. On the basis of the scrutiny of the documentation submitted by the institution, input received from the visiting team report, the NRC in its  $104^{th}$  meeting held on  $15^{th}$   $17^{th}$  July 2006 noted the following compliance required to be made by the institution before the complete and the residual accordance and  $12^{th}$   $12^{th}$  and  $12^{th}$ . before the commencement of the academic session 2006-2007
  - 1. Appoint duly selected staff with the requisite qualification as per NCTE norms and standard and Inform the Regional committee.

In view of the above the Committee decided to issue a conditional recognition to the institution with an annual intake of one unit (100 seats) and also advised to make the compliance of the above preferably within 21 days from the date of issue of this letter.

The Institution shall undertake appointment of staff by a duly constituted selection. committee and ensure selection of candidates possessing qualifications as prescribed under rules. However it is also informed that in case duly qualified staff are not available, relaxation in terms of the requirement relating to passing of NET/SLET/ Ph.D etc., the Institution may approach to the NCTE as per the NCTE Regulations "The National Council for Teacher Education (the criteria for relaxation in qualifications required for appointment to teaching posts in degree level teacher training courses) Regulations, 2005€
